NC Cardinal Library Consortium

NC Cardinal is a consortium of North Carolina public libraries that share an online catalog and integrated library system (ILS), and share library materials with other member libraries. NC Cardinal is managed by the State Library of North Carolina, a division of the NC Department of Natural and Cultural Resources.

54 member libraries* serving 44% of NC residents across 66 counties

NC Cardinal services many counties with high need including: 82% of Helene impacted counties, 75% of designated tier 1 counties, and 68% of tier 2 counties. Membership is growing, adding on average three library systems annually.



NC Cardinal **expands access** to library materials & creates **cost-savings** for local governments

What member libraries & residents get

- Access to a shared library catalog with all member libraries
 - Approximately 62% savings on library catalog software
 - No-cost support for customized features and enhancements
- Ability borrow library materials from any other member library free of charge
 - Sharing library materials increases the libraries' ability to invest in other services such as workforce development workshops, literacy programs, and digital skills training.





8.1 million items are available







In 2024, 617k items were shared between member libraries with a value of nearly \$13 million, with an average value of \$20.90 per item.

NC Cardinal budget & potential federal funding impact

NC Cardinal is funded by member dues and federal funds received from the Institute of Museum & Library Service's Grants to States program, authorized by Congress under the Museum & Library Services Act. NC Cardinal operations and services could be greatly impacted by changes to federal funding. If federal funding was eliminated, NC Cardinal has a projected shortfall of \$245,680 in FY25 and \$1,500,111 in FY26.

Program Manager: Provides strategic oversight of consortium operations including growth and member relations.

Developer: Executes high-level technical support for software customization & modifications.

Trainer: Designs training for member libraries, develops best practices & documentation. **Support Lead:** Manages resolution of service tickets & leads communication with joining libraries.

Project Manager: Leads consortium enhancement projects, manages resource sharing operations, Student Access project, and oversees shared cataloging standards.

All team members participate in highly responsive customer support. Last year the team handled 4,259 support tickets, or approximately 16 per work day, in addition to other project work and responsibilities.
